

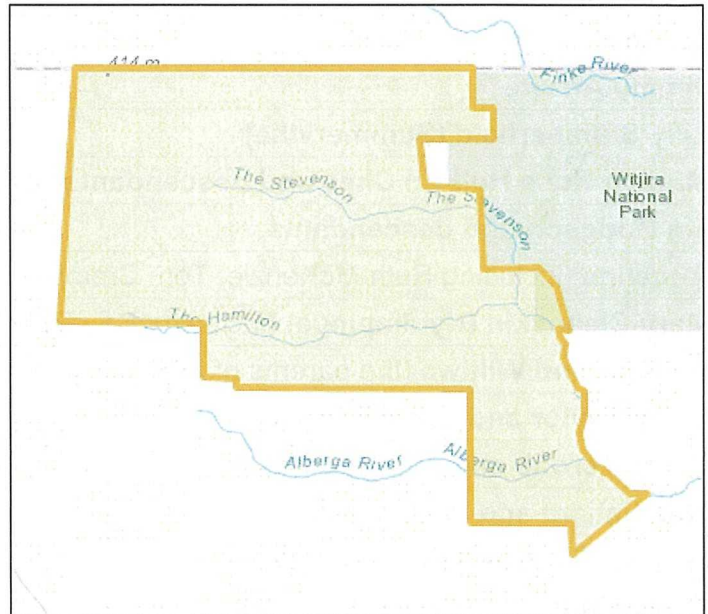

### Who can apply to become a member (eligibility for membership)?

All persons who are at least 18 years of age and a Common Law Holder are eligible for membership of the Corporation.

**Common Law Holders** or Native Title Holders is defined in accordance with the determination for native title and to summarise includes those Lower Southern Arrernte persons who have a traditional connection to the Determination Area (see map), and those Yankunytjatjara and/or Luritja persons who have a spiritual connection to the Determination Area and the Tjukurpa associated with it. All common law holders must also be recognised under the relevant traditional laws and customs by other Native Title Holders as having rights and interests in the Determination Area. Common Law Holder includes those apicals/individuals and descendants named below (and in Schedule 3 and 4 of the Rulebook).
